1. Admission shall be provisional, subject to fulfilment of statutory norms as per the admission guidelines and production of all the relevant documents **in original** for verification, as mentioned in the advertisement notification.
2. Candidates are advised to complete their admission formalities on **2<sup>nd</sup> September 2025** in the **Counselling-cum-Evaluation Centre** of the Institute.



3. For candidates in reserved categories, the production of valid category certificates is mandatory at the time of admission. In case of OBC-NCL and EWS category, the certificate must have been issued on or after **1<sup>st</sup> April 2025**, by the competent authority not below the rank of Tehsildar or a Government issued online verifiable certificate, which must be valid till 31<sup>st</sup> August 2025 or the date of physical reporting at the admitting institute, whichever is later.
4. PwD candidates will be assessed by the Medical Board at the time of admission. Admission under the PwD category will be subject to the condition that the candidates have disability not below 40% as assessed and reported by the Medical Board.
5. The sponsored candidates will be able to complete their admission formalities as per the Institute rules.
