Important Notes:

- 1. The subject experts while evaluation has found errors, repetitions in the question paper of Electrical Engineering Department. Based on their expert advice following decisions have been made:
 - a. For Q. No. 1 both options 'b' and 'c' shall be considered as correct.
 - **b.** Q. No. 16 & 53, 39 & 54, 41 & 55, are repeating in the given pairs, these questions have been cancelled and equal weightage is given to all candidates.
 - **c.** Because of error in Q. No. 48, the said question is cancelled and equal weightage is given to all candidates.
- 2. Since as per GOI instructions, the reservation is to be calculated at the institute level, therefore distribution of reserved category post at department level can be done at the interview level only. Also, after screening the application forms and conducting the screening test, it has been observed that very less number of candidates have been found eligible in the reserved categories. In view of this, the institute has decided to call all the eligible candidates of reserved categories to appear in the interview so that the sufficient representation of reserved category candidates can be ensured at the Institute level.
