Village Nanibough District Kulgam is adopted by NIT Srinagar under UBA. M.F.Wani is the PI of the village. Village survey has been completed in 2018 and as per this survey the village lacks in health system, drinking water, drainage, employment, women literacy etc.

A meeting of RCI M.F. Wani was held with District Development Commissioner Kulgam in 17/07/2017. Various officers of the district participated in the meeting and it was decided to take up various activities as per the survey report to transform the village Nanibough into Model village. However, the progress of developmental works and these activities has not been initiated till date. In order to review the developmental works in this village under UBA.

A meeting of Village Development committee was held today on 6th March 2021 at 7 PM. The following members were present:

The Committee meeting was held under chairmanship of Prof.M.F. Wani, RCI UBA Kashmir. The Progress of UBA implementation was discussed and it was resolved that all activities initiated before three years need to be complete at the earliest.

- A. Drainage system of villages is defunct and during winter and rainy season the villagers face a lot of problems. Rural Development Department has not initiated any drainage system since last three years.
- B. Village is not open defecation free. As per government resolution, the village should have been made open defecation free in 2018.
- C. Solar lights for village have not been installed till date.
- D. Social Welfare centre for women needs to be established for training of stitching and tailoring to the women of the village so that they are made to earn their livelihood.
- E. 15 Computer systems and 10 UPS were provided by NIT Srinagar to the school of adopted village for establishing computer laboratory in Government Middle School Nanibough. Village Development Committee will furnish the progress report of the same and ensure that computer are used in school for teaching of students.
- F. In order to provide livelihood to the villagers, district employment department is requested to implement the Centre Government Schemes in the village for generating employment among the unemployed youth of the village.

- G. Chief Agriculture Officer, Kulgam is requested to implement the schemes for Organic Manure Plant to promote sustainable organic production in the village.
- H. Electric Power supply is shabby, conductors are broken and can lead to loss of human life.
- I. Chief Engineer Public Health Engineering (PHE) Department, is requested to implement out faster rate of scheme approved for the supply of drinking water to the village.
